

## Frequently Used Cannabis Business Entity Filing Forms

**Below** are common forms that need to be filed with the California Secretary of State to create, change or update your Business Entity. The forms below are categorized according to business entity type. There are many State and Local requirements for starting a cannabis business in California.

### Reminder: All Filings and Contents are Available to the Public

Filings and information contained in filings you submit to the Secretary of State are public record, including names, phone numbers, email addresses, and mailing and street addresses, except as provided in statutes. To avoid issues related to identity theft you should avoid using and submitting confidential information in public filings unless specifically required by statute.

The public can view information and download documents contained in the Secretary of State's electronic records using digital search tools and information posted on the Secretary of State's website. Also, please note that individuals and private companies use this public information to create third party access to these records.
