- **Item 1**. Enter the complete name of the farm, ranch, estate or villa.
- **Item 2**. Enter the county where the farm, ranch, estate or villa is located.
- **Item 3.** Enter the complete address of the farm, ranch, estate or villa.
- **Item 4**. Enter the complete name of the registrant (owner and/or lessee) of the farm, ranch, estate or villa.
- **Item 5**. Enter the relationship of the registrants (owners and/or lessees), if there is more than one owner of the farm, ranch, estate or villa.
- **Item 6**. Date and sign the registration. If there is more than one owner and/or lessee of the farm, ranch, estate or villa, the partner(s) or spouse is required to sign.
- Item 7. Enter the name and address of the person or firm to receive the acknowledgment of the filing.
