## Instructions for Completing the Statement of Information (Form LLC-12)

Every California and registered foreign limited liability company must file a Statement of Information with the California Secretary of State, within 90 days of registering with the California Secretary of State, and every two years thereafter during a specific 6-month filing period based on the original registration date, as described in the chart below.

All Statements of Information for limited liability companies can be filed online using our bizfile Online portal at <a href="mailto:bizfileOnline.sos.ca.gov">bizfileOnline.sos.ca.gov</a>.

**Status of LLC:** In order to file Form LLC-12, the status of the LLC **must** be active or suspended/forfeited on the records of the California Secretary of State. The status of the LLC can be checked online on the Secretary of State's Business Search at <a href="mailto:bizfileOnline.sos.ca.gov/search/business">bizfileOnline.sos.ca.gov/search/business</a>. See the <a href="mailto:FTB">FTB</a> Suspension/Forfeiture section below for information about resolving an FTB suspended/forfeited status.

Fees: See chart below. Checks should be made payable to the Secretary of State.

**Copies:** Upon filing, we will return one (1) plain copy of your filed document for free and will certify the copy upon request and payment of a \$5 certification fee.

(Sections 17713.07(b) and 17713.09; California Revenue and Taxation Code section 19141.)

**FTB Suspension/Forfeiture:** If the LLC's status is FTB suspended/forfeited, the status must be resolved with the California Franchise Tax Board (FTB) for the LLC to be returned to active status.
